

PUBLIC CALL FOR PROPOSALS FOR DOCTORATE IN BIOSCIENCES AND BIOTECHNOLOGY 2025

Selection of Candidates for the *Stricto Sensu* Postgraduate Program from the Carlos Chagas Institute / FIOCRUZ-PR

(Accredited by CAPES with concept 5)

The Carlos Chagas Institute, Oswaldo Cruz Paraná Foundation (ICC/FIOCRUZ-PR) makes public, for the knowledge of interested parties, the calendar and rules for the selection of candidates for the Doctoral Course of the *Stricto Sensu* Postgraduate Program in Biosciences and Biotechnology of the ICC/FIOCRUZ-PR (PPGBB-ICC).

1. TARGET AUDIENCE

The Doctorate is multi-professional in nature, requiring candidates to have completed higher education and, preferably, a Master's degree.

2. REGIME AND DURATION

The *Stricto Sensu* Doctorate course in Biosciences and Biotechnology at the Institute Carlos Chagas (PPGBB-ICC) requires dedication of 40 hours per week, with an expected duration of four years (48 months), including the completion and defense of thesis.

3. NUMBER OF VACANCIES

Up to 15 vacancies will be made available , with no forecast yet for the availability of scholarships, with up to one vacancy reserved for candidates who declare themselves to be Persons with Disabilities, three vacancies for candidates who declare themselves to be black (black and brown) and one vacancy for indigenous candidates, in accordance with Ordinance 491/2021, published by the Presidency of Fiocruz in September 2021. The result of the selection process will be valid for six months, counting from the date of enrollment. Any scholarships that may be available will be implemented in order of candidate ranking, with priority given to candidates without employment contracts.

3.1 Affirmative Action vacancies

3.1.1 Candidates who choose to apply for the job reservation system affirmative action vacancies will be defined as opt-in and will comply with



all rules, in accordance with current legislation, and will go through all the steps established in this Public Call. These vacancies will be filled in according to the final overall classification of the group of candidates of each category.

3.1.2 The candidate who meets the requirements for affirmative action vacancies
You must choose, at the time of registration, the modality for which you wish to compete.
3.1.3 Only candidates for the positions designated for
affirmative actions those who, at the time of registration, present all the
documentation required for the Selection Process and the appropriate forms
filled, according to the number of vacancies. The guiding documents,
affirmative action policies and specific forms are available
available in Annexes I and II.

3.1.4 Candidates for affirmative action vacancies who fail to submit any of the specific documents to apply for registration in this vacancy modality, will be automatically reassigned to registration in vacancies intended for general competition.

3.1.5 In case of withdrawal of an affirmative action candidate approved, the vacancy will be filled by the self-declared candidate subsequently classified. If the affirmative action vacancy is not filled, it will be reverted to the demand for broad competition.

4. REGISTRATION

<u>4.1</u> The registration form for the selection process will be completed through Fiocruz Integrated Education System (SIEF). To access it, it is necessary register with Fiocruz's Single Login, following the detailed steps in ANNEX III.

 The project document must contain a maximum of ten pages (A4 size; Arial font 12, 1.5 spacing, 1.5 cm margin), distributed among the items Abstract, Introduction, Objectives, Experimental Approach, Schedule and Bibliographic References.
- o Letter from accredited teacher at PPGBB (https://www.posgraduacao.icc.fiocruz.br/docentes/) declaring that will guide the candidate in case of approval in the selection process.
- o Proof of the curriculum items listed in item 6.2 (on the SIEF platform, this document must be gathered in a single PDF and attached to the *curriculum vitae tab*)
- o Digital copy of undergraduate and master's academic records.
- o Authorization Term: For this selection, authorization from the recording and use of the image and/or voice sound through filling in of Annex IV of this Call.
- o Declaration of reading, understanding and agreement of the call public signed by the candidate in accordance with Annex V.

5.1 All documents listed above must be scanned, readable form, in pdf format (portable document format). The candidate, when send the required documentation, will be responsible for the veracity of all information posted, as well as by observing deadlines. To For each document listed above, a single scanned file must be generated (containing all pages of that document). Each document digitized must have a name compatible with its content. For example, for the undergraduate degree diploma, the scanned document must have the name "Diploma_graduation_first_last_name.pdf". 5.2 At the end of your registration, the system will display a screen with a summary of all information provided and documents attached by the candidate in the system. It is important to review all data before confirming your registration, especially checking that all documents required for this call were entered. Then, after clicking the Confirm button, the candidate will receive by email (at the address provided in the application form) registration) a statement that your registration has been completed. The candidate will wait for the analysis of your data and documents so that your registration can be approved. 5.3 Only registrations made through the registration system will be accepted. electronically through the SIEF platform. Registration implies recognition and acceptance by the candidate of all the conditions set out in this Call for Applications

Public Selection.

5.4 It is the sole responsibility of the candidate to monitor the dissemination of approved registrations. Approved registration is understood as one that, after analysis, is in compliance with the requirements of the Call of Selection.

5.5 Registration closes at **5:00 pm** on the registration deadline verified by email sending time (suggestion).

5.6 For the registration to be **approved**, it is necessary that the date of

receipt of the **digitized version** meets the registration deadline. Registrations

with incomplete documentation or not respecting the models of

specific forms will not be accepted.

5.7 For the candidate's application to be accepted, the supervisor must comply with mandatory teaching activities established in the regulations of the Postgraduate Program in Biosciences and Biotechnology. Applications submitted by teachers with some type of pending in the PPGBB will be analyzed by the Program Board and may be rejected.

6. SELECTION PROCESS

6.1 Research project analysis.

The Selection Committee will assess the candidate's project's adherence to the PPGBB research lines, also considering the feasibility of the scientific proposal and clarity in the project's writing. At this stage, the projects presented by each candidate will be assessed as suitable or not suitable to continue in the selection process.

6.2 Curriculum vitae analysis: 3 points

The Selection Committee will consider the following factors to assign a score from 0 (zero) to 3 (three) for curriculum analysis:

- Have completed scientific initiation or internship in the area of Biosciences and Biotechnology, proven by document or declaration (0.5 points per period of 6 months, maximum possible score of 1 point).
- Scientific articles published in peer-reviewed journals in the area of Biosciences and Biotechnology and/or patents (0.5 points per article as first author in a journal with an impact factor greater than 3.5; 0.25 points per article as first author in a journal with an impact factor less than 3.5; 0.25 points per article as co-author in a journal with an impact factor greater than 3.5, 0.1 points per article as co-author in a journal with an impact factor greater than 3.5, 0.1 points per article as co-author in a journal with an impact factor less than 3.5, 0.5 points per patent obtained, 0.2 points per patent filed). The maximum possible score is 1 point.

6.3 Oral exam:

The oral exam will be conducted remotely by a panel composed of 1 internal member of the PPGBB and 2 external members. The exam will be divided into two stages, lasting up to 30 minutes. In the first stage, the candidate will make a presentation of up to 15 minutes about his/ her academic trajectory and proposal for the Doctorate. Then, the candidate will be questioned by the members of the Selection Committee for up to 15 minutes. Questions may be asked about the candidate's trajectory, as well as about the scientific project presented and theoretical questions related to the major areas of Biosciences and Biotechnology.

The evaluation panel will consider the following factors to assign a grade from 0 (zero) to 7 (seven) for the oral exam:

• The quality of the presentation on the candidate's professional trajectory (maximum of 2 points);

• The candidate's professional maturity and technical-scientific qualification to pursue a Doctorate (up to 3 points);

• Conceptual mastery of the doctoral proposal (up to 2 points).

The successful candidates will be classified by adding the grades of the Oral Exam and Curriculum. The final grade of each candidate will consist of the arithmetic average of the grades awarded by each member of the Selection Committee. Candidates with a final grade lower than 7 will be considered unfit to enter the Doctorate program.

In the event of a tie, the tiebreaker criteria listed below will be adopted in the following order:

- I. the highest score in the oral exam;
- II. candidate's highest chronological age, day/month/year.

7. Filing of appeals at the public selection stages

7.1. The filing of appeals at all stages must be carried out in compliance with the

- f. Photocopy of the Marriage Certificate, in case of a change of name in relation to to the graduation diploma.
