



Selection of Candidates for the Doctorate Program of the Carlos Chagas Institute / FIOCRUZ-PR

(Accredited by CAPES with a rating of 5)

The Carlos Chagas Institute, Oswaldo Cruz Foundation Paraná (ICC/FIOCRUZ-PR) hereby announces, for the information of interested parties, the calendar and rules for the selection of candidates for the Doctorate Program of the Stricto Sensu Graduate Program in Biosciences and Biotechnology of the ICC/FIOCRUZ-PR (PPGBB-ICC).

1. TARGET AUDIENCE

The Doctorate program is multidisciplinary in nature, requiring candidates to have completed a higher education degree and, preferably, a Master's degree.

2. SCHEDULE AND DURATION

The Stricto Sensu Doctorate in Biosciences and Biotechnology at the Carlos Chagas Institute (PPGBB-ICC) requires 40 hours of dedication per week and is expected to last four years (48 months), including the completion and defense of the thesis.

3. NUMBER OF POSITIONS

3.1 Up to 15 positions will be available, with no scholarship availability yet. Up to one spot will be reserved for candidates who self-identify as a person with a disability, three spots for candidates who self-identify as Black (Black and mixed race), and one spot for Indigenous candidates, in accordance with Ordinance 491/2021, published by the Fiocruz Presidency in September 2021. The results of the selection process will be valid until June











30, 2026. Any scholarships available will be implemented in order of candidate classification, with priority given to candidates without employment ties.

3.2 Affirmative Action Positions

- 3.2.1 Candidates who choose to compete under the affirmative action position reservation system will be defined as optants and will comply with all rules, in accordance with current legislation, and will go through all stages established in this Public Call. These positions will be filled according to the final overall ranking of the group of optants in each category.
- 3.2.2 Candidates who meet the requirements for affirmative action positions must choose the category for which they wish to compete at the time of registration.
- 3.2.3 Only those who, at the time of registration, submit all necessary documentation for the Selection Process and the appropriate completed forms, according to the number of vacancies, may compete for the positions reserved for affirmative action candidates. The guiding documents, affirmative action policies, and specific forms are available in ANNEXES I and II. Candidates selected for affirmative action positions will be evaluated by the Carlos Chagas Institute's Self-Identification Committee.
- 3.2.4 Candidates for affirmative action positions who fail to submit any of the specific documents required to apply for this position will be automatically reassigned to open competition positions.
- 3.2.5 If a candidate withdraws from an approved affirmative action position, the position will be filled by the self-declared candidate who was subsequently selected. If the affirmative action position is not filled, it will be reverted to open competition.







4. REGISTRATION

- 4.1 The application form for the selection process will be made available through the Fiocruz Integrated Education System (SIEF). To access it, you must register with Fiocruz's Single Login by following the steps detailed in ANNEX III.
- 4.2 All selection steps must be made available through the following websites: SIEF Platform; PPGBB page (https://www.posgraduacao.icc.fiocruz.br/). Some information may also be posted on the Instagram profile @ppgbbicc. Candidates must monitor the results of the Selection Process through the SIEF platform at https://acesso.fiocruz.br. By providing their login and password, candidates can follow all updates on the Selection Process (announcement of results and appeals). No information will be provided over the phone and/or WhatsApp.

5. APPLICATION DOCUMENTS (all to be submitted electronically)

- Copy of the candidate's Lattes CV, completed and updated on the Lattes Platform (https://lattes.cnpq.br/);
- Descriptive memorial, detailing the candidate's academic and professional career. The memorial document must be a maximum of three pages (A4 size; Arial 12 font, 1.5 spacing, 1.5 cm margins);
- Research project, detailing the proposal to be developed for the doctorate. The project document must be a maximum of ten pages (A4 size; Arial 12 font, 1.5 spacing, 1.5 cm margins), divided into the following sections: Abstract, Introduction, Objectives, Experimental Approach, Schedule, and References; • Letter from a professor accredited by the PPGBB (https://www.posgraduacao.icc.fiocruz.br/docentes/) stating that they will advise the candidate if approved in the selection process;
- Proof of the curriculum items listed in item 6.2 (on the SIEF platform, this document must be compiled into a single PDF and attached to the curriculum vitae tab);
- Digital copy of undergraduate and master's transcripts;

- Authorization Form: For this selection process, authorization for the recording and use of images and/or voice sounds is required by completing Annex IV of this Call;
- Declaration of reading, understanding, and agreement to the public call signed by the candidate in accordance with Annex V.
- 5.1 All documents listed above must be scanned, legibly, in PDF format (portable document format). By submitting the required documentation, the candidate is responsible for the accuracy of all information posted and for meeting the deadlines. For each document listed above, a single scanned file (containing all pages of that document) must be generated. Each scanned document must have a name consistent with its content. For example, for an undergraduate diploma, the scanned document should be named "Diploma graduação nome sobrenome.pdf".
- 5.2 At the end of your registration, the system will display a screen with a summary of all the information provided and documents attached by the candidate. It is important to review all data before confirming your registration, especially to ensure that all required documents have been entered. After clicking the Confirm button, the candidate will receive an email (to the address provided on the registration form) confirming that their registration has been completed. The candidate will wait for their data and documents to be reviewed for approval.
- 5.3 Only applications submitted through the SIEF platform's electronic registration system will be accepted. Registration implies the candidate's acknowledgment and acceptance of all the conditions set forth in this Public Selection Process.
- 5.4 It is the sole responsibility of the candidate to monitor the dissemination of approved applications. An approved application is one that, after review, complies with the requirements of the Selection Process.
- 5.5 Registration closes at 11:59 p.m. on the application deadline, as verified by the email's sending time.











5.6 For the application to be approved, the date of receipt of the digital version must meet the application deadline. Applications with incomplete documentation or those that do not comply with the specific form templates will not be accepted.

5.7 For the candidate's application to be accepted, the advisor must comply with the mandatory teaching activities established in the bylaws of the Graduate Program in Biosciences and Biotechnology. Applications submitted by faculty members with any type of pending issue with the PPGBB will be analyzed by the Program Board and may be rejected.

6. SELECTION PROCESS

6.1 Research Project Analysis. The Selection Committee will evaluate the candidate's project's adherence to the PPGBB research lines, also considering the feasibility of the scientific proposal and clarity in the project's writing. At this stage, the projects presented by each candidate will be evaluated as suitable or unsuitable for continuing in the selection process.

6.2 Resume Analysis: 3 Points

The Selection Committee will consider the following factors to assign a score from 0 (zero) to 3 (three) for the resume analysis:

- Having completed a scientific initiation or internship in the field of Biosciences and Biotechnology, proven by document or statement (0.5 points per 6-month period, maximum possible score of 1 point);
- Scientific articles published in peer-reviewed journals in the field of Biosciences and Biotechnology and/or patents (0.5 points per article as first author in a journal with an impact factor greater than 3.5; 0.25 points per article as first author in a journal with an impact factor less than 3.5; 0.25 points per article as co-author in a journal with an impact factor greater than 3.5; 0.1 points per article as co-author in a journal with an









impact factor less than 3.5; 0.5 points per patent obtained; 0.2 points per patent filed). The maximum possible score is 1 point;

- Having defended a master's degree (1 point);
- Passing the Master's qualification exam without any outstanding issues, proven by a signed report (0.5 points).

6.3 Oral Exam

- 6.3.1 The oral exam will be administered remotely by a panel composed of 1 internal member of the PPGBB and 2 external members. The exam will be divided into two stages, each lasting up to 30 minutes. In the first stage, the candidate will present a presentation of up to 15 minutes on their academic background and doctoral proposal. The candidate will then be questioned by members of the Selection Committee for up to 15 minutes. Questions may be asked about the candidate's background, as well as the scientific project presented and theoretical questions related to the major areas of Biosciences and Biotechnology.
- 6.3.2 The evaluation committee will consider the following factors when assigning a score from 0 (zero) to 7 (seven) for the oral exam:
- The quality of the presentation on the candidate's professional background (maximum of 2 points);
- The candidate's professional maturity and technical-scientific qualifications for pursuing a doctoral degree (up to 3 points);
- Conceptual mastery of the doctoral proposal (up to 2 points).
- 6.4 Final Grade and Ranking of Candidates.
- 6.4.1 Successful candidates will be ranked based on the sum of their Oral Exam and Curriculum Vitae scores. Each candidate's final grade will be the arithmetic average of











the scores assigned by each member of the Selection Committee. Candidates with a final grade lower than 7 will be considered ineligible for the Doctorate program.

- 6.4.2 In the event of a tie, the tiebreaker criteria listed below will be applied in the following order:
- (1) the highest score on the Oral Exam;
- (2) the candidate's oldest chronological age, day/month/year.

7. FILING APPEALS IN THE PUBLIC SELECTION STAGES

7.1 Appeals for all stages must be submitted within the deadlines published in the schedule in item 9 of this public selection process. The Program Selection Committee will have 48 hours to respond to the candidate's appeal. After the final results for each stage are published, no further appeals will be accepted. Under no circumstances will requests for reconsideration of the Selection Committee's decision regarding the appeal be accepted.

7.2 To file an appeal regarding the selection stages, the candidate must follow these steps:

- 1. Access the "Fiocruz Single Login" and select "Fiocruz Services" in the left-hand "Education" Click and then "My Applications" menu. on on (https://acesso.fiocruz.br);
- 2. Click on the + sign next to the application option;
- 3. Click "Access";
- 4. Click the gear icon;
- 5. Click "Request Appeal"; and then click "Next";
- Choose the type of appeal, write the justification, and attach a file, if applicable.
- If it is necessary to attach more than one document, they must be converted into a single file.

7.3 The candidate must request access to the document corresponding to each stage before writing the appeal in SIEF, as only one appeal will be allowed through the system.

- Stage 1 Registration: the candidate can access the list of pending documentation through MeuSief;
- Stage 2 Oral Exam: the candidate can access the exam correction report by requesting it from the virtual exam platform's customer service department;
- Stage 3 Interview: The candidate may request the average of the scores received in the interview by emailing Seleçãoppgbb@gmail.com.

8. ENROLLMENT

At this stage, successful candidates must attach the documents listed below to the SIEF portal (to complete their enrollment). Failure to submit any of these documents will result in disqualification.

- 1. Photocopy of the Undergraduate Diploma (front and back);
- 2. Photocopy of the Undergraduate Transcript;
- 3. Photocopy of the Identification Document (RG) with photo (front and back);
- 4. Photocopy of the CPF (Individual Taxpayer Registry) (front and back);
- 5. A 3x4 digital photograph;
- 6. Photocopy of the Marriage Certificate, if there has been a name change in relation to the undergraduate diploma.
- 7. Completed and signed Annex VII
- 8. Only candidates who declare that they have the available course load and a statement of authorization from their immediate supervisor (ANNEXES VI) to take the course, in accordance with the requirements of Program.

Digital versions must be clear, within the validity period, and images cannot be thumbnails. Photocopies must be included in the SIEF (A4 format).

- 3. Select one of the options: Brazilian, foreigner without a CPF, or foreigner with a CPF;
- 4. Fill in your personal information, read the terms of use, and confirm the "I have read and agree to the terms of use" field;
- 5. Click the "I am not a robot" option and then click "Next";
- 6. Verify that your email address is correct and click "Next" to activate your account;
- 7. Check your email inbox for the access code. Enter the access code received by email in the "6-digit code" field and then click "Verify";
- 8. A confirmation message will appear: "Your account has been successfully created." Click "Authenticate";
- 9. After registering, or if you are already registered with "Fiocruz Single Login," access the "Fiocruz Services" option in the menu on the left. Click "Education" and then "Open Public Calls";
- 10. In the "Level" option, choose "Master's" and "Filter";
- 11. Select the "Master's in Biosciences and Biotechnology 2026" option;
- 12. On the next page, click "Register";
- 13. Complete all required fields on the registration form, clicking "Next" on each page. In the Education field, you will need to include information about your undergraduate degree;
- 14. In the case of a reservation For Affirmative Action vacancies, the candidate must select one during registration;
- 15. Add the required documents and click "Next";
